

**CITY OF HAZELWOOD
REGULAR COUNCIL MEETING
OCTOBER 20, 2021**

CALL TO ORDER

A regular meeting of the Hazelwood City Council was called to order by Mayor Matthew G. Robinson at 7:34 p.m. on Wednesday, October 20, 2021 in the Council Chambers of Hazelwood City Hall, 415 Elm Grove Lane.

In response to the coronavirus (COVID-19) public health emergency, some members of the City Council attended in-person in the Council Chambers at Hazelwood City Hall and others attended and participated by video conference in accord with Section 610.015, RSMo (“All votes taken by roll call in meetings of a public governmental body consisting of members who are all elected ... shall be cast by members ... who are physically present ... or who are participating via videoconferencing.”) It was impossible and impractical to hold the meeting in a manner physically accessible by the public. Section 610.020.2, RSMo (“Each meeting shall be held at a place reasonably accessible to the public ... unless for good cause such a place ... is impossible or impractical.”) Public access to the meeting was accommodated in person and via access to video conference pursuant to notice provided in accord with Section 610.020, RSMo.;

Mayor Robinson asked those present to join in a moment of silent meditation followed by the Pledge of Allegiance.

Mrs. Lowery administered the oath of office to Tim Parson who was recently appointed to the City Plan Commission.

PROCLAMATIONS AND RESOLUTIONS

IMPERIAL DADE CHAPTER 100 INDUCEMENT

Mayor Robinson called for the reading of a resolution authorizing City staff and consultants to take certain actions with respect to a proposed project for Imperial Dade.

Mark Spykerman of Gilmore and Bell, the City’s bond counsel, stated Imperial Dade intends to lease space in the Hazelwood TradePort Building 6 to expand its food packaging distribution operations. The expansion would include an \$8 million investment in equipment and the creation of 165 jobs over five years. Mr. Spykerman stated the company has asked the City to consider using Chapter 100 industrial revenue bonds to facilitate 10 years of personal property tax abatement. The proposed tax abatement would

be contingent on the company creating 165 jobs. Mr. Spykerman stated if the inducement resolution were to be adopted, the tax abatement ordinance would be presented at a future Council meeting.

Doug Rasmussen of Steadfast City, an economic development consulting firm, gave a PowerPoint presentation and an overview of the company. Mr. Rasmussen stated the 10-year lease would start in April 2022. The proposed project would consolidate 110 new positions into Hazelwood at \$58,425 average salary.

There were no objections and Resolution 2106 was read by title only:

CITY MANAGER'S REPORT

PURCHASE DUMP TRUCK Public Works Director David Stewart reported staff recommends the purchase of a 2022 Ford F450 with snowplow and spreader equipment from Bommarito Ford at a cost not to exceed \$66,787.

Mr. Stewart stated in the current fiscal year Capital Fund budget includes \$65,000 to replace a plow truck in the Maintenance Division of the Public Works Department. Bommarito Ford of Hazelwood will match the state bid amount of \$66,787. This will replace the 2009 F450 in the fleet.

Mr. Aubuchon moved, seconded by Ms. Matlock, to concur with the staff recommendation to purchase a plow truck for the Maintenance Division and to place the draft bill on this agenda for introduction. The motion passed unanimously and the bill was added to the agenda as item 17.a.
